RE: REMINDER, Action Required: Inventory of THC-Infused Beverages Tomorrow

A [new law passed by the legislature](#) requires any business offering THC-infused beverages for retail sale to conduct an inventory of THC-infused beverages in its possession as of tomorrow, **Tuesday, May 14, 2024**. This inventory does not include beverages that are considered cannabis.

The [new law](#) also requires a \$1 fee for every beverage counted in the inventory.

*If you do **not** offer beverages containing THC for retail sale, you may disregard this notice.*

THC-infused beverages are non-alcoholic drinks that contain THC. This might be displayed as “hemp-derived,” Delta-8, Delta-9, Delta-10, THCA, HHC or similar. If you are unsure whether you have a THC-infused beverage, contact your supplier.

REPORTING REQUIREMENT FOR MAY 14, 2024, INVENTORY

Conduct an inventory of all THC-infused beverages in your possession as of Tuesday, May 14, 2024. This includes all product in your possession, even product that is no longer intended for sale.

No later than June 15, 2024, you must:

1. Report to the department (through [eLicense](#)) the number of containers of THC-infused beverages identified in their May 14, 2024 inventory.
 - Example: Four-pack of cans counts as four containers.
2. Pay a \$1 fee for each infused beverage container reported in the inventory.

To report your inventory and pay the fee, log into your account and use “License Maintenance” on or after May 14, 2024, but not later than June 15, 2024. When you report your inventory in [eLicense](#), you must pay the related fee.

If you have multiple locations, you must conduct and report a separate inventory for each location.

TO SELL LEGACY THC-INFUSED BEVERAGES ON OR AFTER JULY 1, 2024:

A legacy THC-infused beverage contains no more than one milligram of THC per serving and no more than five milligrams of THC per container.

To continue to offer legacy THC-infused beverages for retail sale from July 1, 2024 through September 30, 2024, you must be granted a waiver by the Department. When you report the results from your May 14, 2024 inventory, you may also request the waiver in eLicense. If you do not request a waiver, you cannot continue selling the THC- infused beverages you had in stock that fail to comply with the new THC limit and labeling requirements.
