

Instructions on How to Pay Your Infused Beverage Container Fee for Cannabis Retail Establishments

Pursuant to Section 6(c) of [Public Act 24-76](#), “On October 1, 2024, and every six months thereafter, each dispensary facility, hybrid retailer or retailer shall remit payment to the department for each infused beverage container and legacy infused beverage container sold during the preceding six-month period.”

THC Infused Beverage Sales Definitions

Please review the following definitions before going forward:

- **Infused Beverage** means a beverage that:
 1. is not an alcoholic beverage, as defined in section 30-1 of the general statutes,
 2. is intended for human consumption, and
 3. contains, or is advertised, labeled or offered for sale as containing, total THC that is not greater than three milligrams per container
- **Legacy Infused Beverage** means a beverage that:
 1. is not an alcoholic beverage, as defined in section 30-1 of the general statutes,
 2. is intended for human consumption, and
 3. contains, or is advertised, labeled or offered for sale as containing, THC, as defined in section 21a-240 of the general statutes, as amended by this act, and
 4. as of June 30, 2024, is in compliance with:
 1. the provisions of RERACA, as defined in section 21a-420 of the general statutes, as amended by this act, and
 2. the policies and procedures issued by the Commissioner of Consumer Protection to implement, and any regulations adopted pursuant to, RERACA, as defined in section 21a-420 of the general statutes, as amended by this act

Note: No Legacy Infused Beverage may be sold in Connecticut beginning October 1, 2024
