Organizational structure – The Board of Firearms Permit Examiners is comprised of nine members appointed by the Governor to serve during his term and until their successors are appointed and qualify. The members are appointed from nominees of the Commissioner the Department of Emergency Services and Public Protection, **Det. Gudrun Johnson**, Connecticut Police Chiefs Association, **Chief Carl Rosensweig**, Commissioner of the Department of Energy and Environmental Protection, **Colonel Chris Lewis**, Connecticut State Rifles and Revolvers Association, Inc., **Colonel Kyle E. Overturf**, Ye Connecticut Gun Guild, Inc., **Stephen Sanetti, Esq.**, Commissioner of the Dept. of Mental Health and Addiction Services, **Dr. Cynthia Conrad** and a vacancy to be appointed by the Chief Court Administrator. Two public members, **Attorney Carolyn Futtner** and **Mr. Elbert Gray** are members appointed by the Governor with at least one member of the Board who shall be a lawyer licensed to practice in Connecticut and who shall act as Chairman of the Board during the hearing of appeals. **Attorney Carolyn M. Futtner, Esq.** serves as Chairman. Members are volunteers and are compensated only for mileage and sustenance.

Mission

The Board of Firearms Permit Examiners' mission is to provide a means of appeal, through administrative hearings, for those have been denied a local temporary pistol permit or had a state pistol permit revoked. In addition, citizens aggrieved by any denial to issue or renew a permit under the provisions of Connecticut General Statute section 29-28 or 29-36f, or revocation of a permit issued, or refusal or failure of any issuing authority to furnish an application, may appeal to the board. The Board provides a uniform interpretation and application of firearm laws.

Statutory Responsibility

The statutory responsibility of the Board is to administer and enforce the provisions of Connecticut General Statute Section 29-32b. Under that section, the Board has the responsibility of making inquires and investigations, taking testimony and rendering decisions, in connection with appeals brought to the Board, by persons aggrieved by the action or inaction

of the Issuing Authorities, local Police Chiefs or First Selectmen. On such appeal the board shall inquire into and determine the facts, de novo, and unless it finds that such a refusal, limitation or revocation, or such refusal or failure to supply an application, as the case may be, would be for just and proper cause, it shall order such permit or certificate to be issued, renewed or restored, or the limitation removed or modified, as the case may be.

Public Service

The eight Board Members are volunteers who served at **21** meetings and heard **193** administrative appeals in the fiscal year 2024.

Achievements

In FY 2024

The Board received **781** new requests to appeal the denial or revocation of a state pistol permit or the denial of local temporary pistol permit. The Board held **21 meetings** with an average of **9 cases** scheduled per meeting. Two meetings were cancelled due to lack of quorum. A total of **193 cases** were resolved by the Board through administrative hearings. Of the **193 cases**; **45** decisions were in favor of the appellant being reinstated or issued a permit, **112** decisions were upheld for the Commissioner, Chief or First Selectman's to deny or revoke a pistol permit. **3** cases were continued within the 2024 F/Y and **35** withdrew their appeal at the hearing. 1 case was "mark off" State and Local Authorities reissued or issued 463 cases, and 76 cases withdrew prior to the hearings. There were also **6** appellant who passed away prior to their hearing date. There were **16 dormancies**, failure to pursue, cases.

Presently (**8/30/2024**) there are **1217** cases on the schedule waiting for a hearing, this changes weekly.
