Pursuant to [C.G.S. § 19a-754j](#), the Office of Health Strategy (OHS) will hold its annual Informational Public Hearing on the Healthcare Benchmark Results.

The hearing examines healthcare affordability, including the findings from the most recent report prepared pursuant to [C.G.S. § 19a-754h](#), the impact of healthcare costs on consumers, the main drivers of increased healthcare spending, and provider and healthcare payer payment and utilization trends, with particular attention to factors that contribute to spending growth within the state of Connecticut's health care system.
